Equifax Breach

The credit reporting company, Equifax, has announced a cybersecurity incident that potentially could impact 143 million consumers.

Equifax has established a dedicated website, www.equifaxsecurity2017.com, to help consumers determine if their information has been impacted and to sign up for credit file monitoring and identity theft protection.

The program offered is **TrustID Premier**. It includes 3-Bureau credit monitoring of Equifax, Experian and TransUnion credit reports; copies of Equifax credit reports; the ability to lock and unlock Equifax credit reports; identity theft insurance; and Internet scanning for Social Security numbers - all complimentary to U.S. consumers for one year.
